

MODERE EXPERIENCES TERMS AND CONDITIONS

ELIGIBILITY

Modere Experiences Sweepstakes (“Sweepstakes”) is open to Customers of Modere Europe BVBA (“Modere”, “Sponsor”) who are residents of one of the European countries served by Modere and who are 18 years of age or older as of date of entry. Employees of Modere and Sales Promotions („Administrator”), employees of advertising and promotion agencies involved with these Sweepstakes, parent companies, subsidiaries, divisions, affiliates and related companies (collectively, the “Promotion Entities”), their immediate family members (parents, spouse, grandparents, siblings, children or grandchildren) and/or those living in the same household, are not eligible to participate or win. 4. PRIZES
